#### **Legislative Session Update 2023**

Focus on Rep Lesser's Post-Partum Medicaid Coverage (to 1 year), extension of coverage for pregnancy to 250% FPL, and contraception coverage to 250% FPL. AUCH will be watching the Opioid Settlement proposals and work to have AUCH members included. Jan 24<sup>th</sup> AUCH will host a presentation to legislators on Integrated care featuring the programs at Family Health Care and Carbon Medical. All are welcome to attend, Sarah sent the details out last week. Please RSVP and consider inviting your legislators to meet you there. Keith suggested PP mental health care is the key prevention opportunity for women. Let Rachel know if you want to get the AUCH Bill Tracker weekly.

**Long COVID needs** at your clinic- interest in presentation and resources. See attached list and watch for a presentation upcoming.

**HIV care** at your center- Kurt has a longstanding HIV care practice at Midtown in partnership with Clinic 1A and Dr. Rosado. We will connect him with Ben Boyer from Bear Lake as he sees the need for a practice there.

**Scribes-** discussed advances of use of scribes at various centers. Keith to send a contact for a provider using a "glasses" model (this was found to be cost prohibitive for non-English care delivery for Keith) and Michele can send the name of the book she has used to train their scribe successfully.

**Value Based care-** no new updates from Medicaid, but process proceeds, we will let you know when Scope Change process is set. AUCH is contracting with Molina for a bi-directional data feed pilot with the Azara DRVS platform, more to come.
