Top Issues / Best Practice Sharing (Roundtable)	<p>Round Robin: •</p> <ul style="list-style-type: none"> • 4th Street indicated they have been having trouble seeking Medicaid reimbursement for the 500+ COVID Vaccinations they have administered to date. <ul style="list-style-type: none"> ○ COVID Vaccine administration claims must be submitted to state Medicaid even for patients under the MCO plans. ○ State Medicaid has not paid claims submitted both with and without the T1015 code. ○ Jim will be having a call with Medicaid on Monday to discuss. He will report back on what they instruct to do with the claims. • Kaitlynn is working with Wayne to resolve the issue with Medicaid secondary payer issue. Information on how these unpaid claims should be resubmitted will be shared once a solution is determined. • Enterprise is still pursuing COVID Vaccine doses for their health center.
