



# VOTING IN UTAH 2022

## Frequently Asked Questions



### WHEN IS THE 2022 GENERAL ELECTION?

The General Election will be held on **Tuesday, November 8, 2022.**

### WHEN IS THE DEADLINE TO REGISTER TO VOTE FOR THE 2022 GENERAL ELECTION?

The deadline to register to vote for the 2022 General Election online is October 28, 2022 by 5:00 PM MST. Any mailed-in Utah voter registration forms must be received by the County Clerk's office by 5:00 PM MST on October 28, 2022. You can visit [vote.utah.gov](https://vote.utah.gov) to complete either the online or paper form.

Same day voter-registration is also available if you are voting in person on Election Day or voting early.

### WHO CAN REGISTER TO VOTE IN UTAH?

To register to vote in Utah, an applicant must:

- be a citizen of the United States
- have resided in Utah for 30 days immediately before the next election
- be at least 18 years old on or before the next election
- not be convicted of a felony **and** not currently incarcerated for commission of a felony

### HOW DO I KNOW IF I AM REGISTERED TO VOTE? WHAT IF MY MAILING ADDRESS HAS CHANGED?

You may check your online voter registration status/update your mailing address online if you have an active Utah ID at: [vote.utah.gov](https://vote.utah.gov).

If you do not have an active Utah ID, you can contact the Office of the Utah Lieutenant Governor at (801) 538-1041 to check your voter registration status and mailing address.

### HOW CAN I VOTE?

You may vote by mail, vote early at early voting locations, and in-person on Election Day. You can find voting locations here: <https://votesearch.utah.gov/voter-search/search/search-by-address/how-and-where-can-i-vote>

### DO I NEED TO SHOW ID TO VOTE IN-PERSON?

### DO I NEED A PERMANENT RESIDENCE/MAILING ADDRESS TO VOTE?

No, you do not need a permanent residence and/or mailing address to vote in Utah. You may list an intersection or shelter as your residential address, and some community sites may offer to serve as your mailing address, such as libraries. You may reach out to these organizations to see if they would be willing to serve as your mailing address where you can pick up your ballot. **You may not drop off your completed ballot at these locations.**

Your mailing address is important, as that is where your mail-in ballot will be delivered. If you have no access to a secure mailing address, you may still vote in-person on Election Day or vote early at your County Clerk's office.

### DO I HAVE TO REQUEST A MAIL-IN BALLOT IF I'D LIKE TO VOTE BY MAIL?

No, mail-in ballots will be sent to all registered voters' mailing addresses. If you register to vote too close to Election Day, there is a chance you may not receive your mail-in ballot in time. You can always vote in-person on Election Day.

### WHERE DO I DROP OFF MY MAIL-IN BALLOT?

Mail-in ballots may be mailed back via USPS as long as they are **postmarked** by the day before Election Day, November 7, 2022.
